

## **FINANCIAL ASSISTANCE FOR PURCHASE OF POWER BLOCK**



### **Objective:**

The fishing industry in the State depends to a large extent on labour from outside the state. There is lot of uncertainty and the timely availability of this labour is crucial to the industry and many times it renders some of the vessels unoperational.

The purse seine net which is operated for catching pelagic fish requires about 20-25 crew (labours) for its operation. In order to reduce the dependency on labour to some extent it is proposed to assist financially by providing the power block.

### **Extent of Subsidy:**

The beneficiary will be entitled for financial assistance to the extent of 25% of the cost limited to Rs. 1.50 lakhs (Rupees One lakh Fifty Thousand). They can avail the Subsidy once in their lifetime.

### **Criteria to Avail:**

The beneficiary has to obtain the prescribed application form from the office of the Directorate of Fisheries, Panaji, Block Development Officer of respective Taluka/Fisheries Surveyor of Fisheries working in the concerned Panchayat. The form duly filled has to be forwarded to the F.O/F.S of Fisheries along with the following documents (all in duplicate):

1. Application in prescribed form.
2. Vessel Registration Certificate
3. Valid Purse seine net license and fishing license for the current year.
4. Original Quotation authorized dealer.
5. Seaworthiness report for Authorized Marine Surveyor.
6. Inspection report of Fisheries Officer
7. Bank letter if applicable
8. Mandate Form (2 copies)
