

DEVELOPMENT OF MODEL FISHERMEN VILLAGE (HOUSING)



Objective:

This scheme has been introduced to uplift the traditional Fishermen community to construct their new house/renovate the Kacha structure so that they have a better place to live.

Extent of Subsidy:

Beneficiary will be eligible for the financial assistance of Rs.75,000/- . They can avail the Subsidy **once in their lifetime.**

How to avail:

The beneficiary has to obtain the prescribed application form from the office of the Directorate of Fisheries, Panaji, Block Development Officer of respective Taluka/-Fisheries Surveyor of Fisheries working in the concerned Panchayat. The form duly filled has to be forwarded to the F.O/-F.S of Fisheries along with the following documents:

2. Birth certificate/ Baptism certificate
3. Net licence or Vessel Registration Certificate of canoe
4. License /NOC from Village Panchayat/Municipality.
