### DF/ENF/ICARDS GOVT/86

In exercise of the powers conferred by section 28 of the Goa, Daman and Diu Marine Fishing Regulation Act, 1980 (3 of 1981), the Government of Goa hereby makes the following rules so as to amend the Goa, Daman and Diu Marine Fishing Regulation Rules, 1982, namely:-

- 1. Short title and commencement.— (1) These rules may be called the Goa Marine Fishing Regulation (First Amendment) Rules, 2012.
  - (2) They shall come into force at once.
- 2. Amendment of rule 6.— In rule 6 of the Goa, Daman and Diu Marine Fishing Regulation Rules, 1982, after sub-rule (5), the following sub-rule shall be inserted, namely:-

- "(6) Every vessel registered under this rule which is venturing into the sea for fishing shall adopt the color code assigned to the State of Goa and possess:-
  - (a) the photo identity cards of all the crew members as issued by Director of Fisheries:
  - (b) fishing vessel licence issued under sub-rule (3) of rule 3 of these Rules;
  - (c) fishing net licence issued under sub-rule (2) of rule 4 of these Rules;
  - (d) certificate of registration of fishing vessel issued under sub-rule (3) of rule 6 of these Rules; and
  - (e) sufficient number of the safety equipments like life jackets, life bouys".
