# DF/ENF/RULE AMENDMENT/G-/109/2022-23

In exercise of the powers conferred by section 28 of the Goa Marine Fishing Regulation Act, 1980 (Act 3 of 1981), and all other powers enabling it in this behalf, the Government of Goa hereby makes the following rules so as to further amend the Goa Marine Fishing Regulation Rules, 1982, namely:—

- 1. Short title and commencement.— (1) These rules may be called the Goa Marine Fishing Regulation (Seventh Amendment) Rules, 2023.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Amendment of rule 3.— In rule 3 of the Goa Marine Fishing Regulation Rules, 1982 (herein after referred to as the "principal Rules"),—
  - (i) in sub-rule (1), for the existing Table, the following Table shall be substituted, namely:—

- (ii) in sub-rule (4), for the letters and figures "Rs. 210/-" and "Rs. 250/-", the letters and figures "Rs. 1,000/-" and "Rs. 5,000/-" shall be respectively substituted;
- 3. Amendment of rule 4. In rule 4 of the principal Rules,—

in sub-rule (2), for the letters and figures "Rs. 100/-" and "Rs. 300/-", the letters and figures "Rs. 1,000/-" and "Rs. 3,000/-" shall be respectively substituted.

- 4. Amendment of rule 11.— In rule 11 of the principal Rules,—
  - (i) for sub-rule 6, the following sub-rule shall be substituted, namely:—
    - (6) Where after such enquiry the accused person is found to be guilty, the adjudicating officer shall direct him to pay such penalty not exceeding,—
    - (a) five thousand rupees, if the value of the fish involved is one thousand rupees or less; or
    - (b) five times the value of the fish, if the value of the fish involved is more than one thousand rupees; or
    - (c) five thousand rupees, in any other case, being a case not involving in any fish, as may be adjudged by the adjudicating officer; and
    - (d) fifty thousand rupees in case of use or carriage or installation of unregistered fishing gear or unauthorised fishing equipment such as LED lights, fish light attractors or any other light equipment.";
  - (ii) after sub-rule (6), the following sub-rule shall be inserted, namely:—
    - "(6A) In addition to any penalty that may be imposed under sub-rule (6), the adjudicating officer may direct that,—
    - (a) the registration certificate of the fishing vessel which has been referred to in sub-section (1) of section 20 or the licence, any condition of which has been contravened, shall be,—
    - (i) cancelled or revoked, as the case may be; or

- (ii) suspended for such period as the adjudicating officer deems fit; or
- (b) the fish, accessories such as light equipment etc., that might have been impounded or seized or the proceeds thereof as the case may be, shall be forfeited to the Government".
- 5. Substitution of Schedule.— In the principal Rules, for the existing Schedule appended thereto the following Schedule shall be substituted, namely:—
