In exercise of the powers conferred by sub-section (1) of section 4 of the Goa Marine Fishing Regulation Act, 1980 (Act 3 of 1981) and in supersession of the Government Order No. ENF/FSH/15 dated 28-03-2002 published in the Official Gazette, Series I No. 2, dated 11-04-2002, the Government of Goa, having regard to the need to maintain Law and Order in the sea, hereby prohibits fishing by any means and by any fishing vessel including anchoring in the following areas (each marked by four marker buoys), the co-ordinates of which are specified in the Schedule below, with immediate effect.
