## **Public Notice**

Sub:- Regarding Spot Quotation for Hiring of Private Fishing Vessel for SagarKavach (Goa) 01/24

Sealed Quotation is here by invited for the hiring of the fishing vessels from 25<sup>th</sup> to 27<sup>th</sup> March 2024 for the coastal security exercise "Sagar Kavach (Goa) 01/24" which is scheduled on 26th -27th March 2024. The Quotations shall be submitted to the Office of the Directorate of Fisheries, Dayanand Bandodkar Marg Panaji on or before 15/03/2024.

Terms and conditions are as follows:

- 1. The length of the fishing vessel shall be above 15 mts. and should be attached with small dingy/ canoe to enable operations during the exercise.
- 2. Fishing vessels participated earlier in the exercise shall not be allowed to participate in the upcoming exercise.
- 3. The fishing vessels should be equipped with communication, tracking and safety equipments such as VHF, AIS/ transponders, GPS, lifejackets and life buoys, fire fighting appliance etc and their should be sufficient no. of crew on vessel.
- 4. Fishing vessel should be seaworthy and should be in good condition.
- 5. Fishing vessels should carry sufficient amount of diesel to venture in the deep sea, ration for crew members and water for 3-4 days to cater the basic needs of the crew members.
- 6. Fishing vessels should have proper lights and navigational signals so as to ply during the night time.
- 7. All the crew members boarding the vessel should mandatorily carry QR coded Aadhaar card, Vessel Registration Certificate, fishing licence certificate.
- 8. Fishing vessels should be given at the disposal of Directorate of fisheries for further necessary communication and instructions.
- 9. Tandel and crew members of the fishing vessel shall strictly follow the instruction given on time to time by Security agency during the exercise.

- 10. The quoted amount should include the rate of all charges including hiring of fishing vessel, diesel, crew members etc.
- 11.GST/taxes, if any shall be indicated separately.
- 12. The fishing vessels will have to be insured by the supplier at his own cost to ensure safe delivery. The Department will not be responsible for the damage during the exercise.
- 13. Fishing vessels supplied will be finally accepted only after the inspection by the competent authority appointed for the purpose by the Director of Fisheries whose decision in this regards will be final. If any quantum / any part thereof is rejected, the supplier will have to bear all the expenses incurred return and replacement of the same.
- 14. The payment towards the supply made will be done after submission of attendance certificate from the concern security agency and submission of the bill by the supplier.
- 15. The Directorate of Fisheries reserves the right to negotiate if fishing vessels are found proper as per the specification.
