Whereas, Government desires to amend the Clause 5(a) of the scheme as under;

## **Requirement of documents:**

- a) Following documents shall be attached with application form of Children of Widow Scheme:
- 1. Marriage certificate of the applicant.
- 2. Birth certificate of child/children.
- 3. Death certificate of husband of the applicant.
- 4. Scheduled Tribe certificate of applicant/husband and children issued by competent authority.
- 5. Aadhar card of applicant & beneficiary.
- 6. Family Income certificate issued by competent authority.
- 7. Mandate form/Joint account of beneficiary.

Beneficiaries shall submit the life certificate & Income Certificate in the month of April every year. Life certificate & Income certificate is valid for a period of one year from the date of issue.

All other clauses in the above mentioned scheme remains unchanged.

This amendment shall come into the force from 1<sup>st</sup> April 2025.
