SIX MONTHS FISHERIES TRAINING COURSE

Applications are invited for Six Months Fisheries Training Course starting from 01st July 2025 at Fishermen Training Centre Ela Dhauji, Old Goa.

The course is meant for imparting training in Fishing Craft & Gear, Fundamentals of Navigation & Seamanship, and Maintenance & Operation of Marine Diesel Engine, Weaving and Mending of modern Nets, Seafood Value Addition & Marketing, Aquaculture, and Aquarium making and Swimming.

Candidates having passed minimum VIIIth Std. and between 18-35 years of age are eligible for admission. Preference will be given to Schedule Caste & Schedule Tribe candidates as well as youths from the fishing community having experience at sea. Only 20 Nos. of seats are available for the said course.

The candidates admitted to the course will be paid stipend of Rs. 1000/- per month and Rs. 100/- per day as D.A. during fishing trips.
