

PROCEDURE TO BE FOLLOWED FOR TRANSFER OF NON-MOTORISED/ MOTORISED FISHING CANOE OUTSIDE THE FAMILY (IN CASE OF DEATH OF OWNER)

I. Permission for transfer of non-motorised/ motorised fishing canoe outside the family (in case of death of owner)

Family member has to apply for grant of permission for transfer of non-motorised/ motorised fishing canoe outside the family (in case of death of owner) and should submit the following documents of the transferee:

1. Covering letter from the family Member towards transfer of the fishing canoe along with the supporting Documents (Marriage certificate-incase of spouse/Birth Certificate-incase of children)
2. Original VRC & Original Fishing License Certificate
3. Copy of Death Certificate of owner
4. NOC from all Legal Heirs (Notarised)
5. Copy of Birth Certificate from Competent Authority (of the transferee)
6. Copy of 15 years Residence Certificate issued by Mamlatdar (of the transferee)
7. Copy of QR coded Aadhaar card & Election Card (of the transferee)
8. No Due Certificate from the bank (if any)
9. No Due certificate towards the fishing canoe/Net from the Fisheries Officer.
10. Inspection Report of Fishing Canoe by Fisheries Officer
11. Undertaking from the transferee as per the prescribed format given by Directorate of Fisheries.

NOTE: 1. After scrutinising the application, the permission shall be granted to the transferee.
2. Checklist for permission for transfer of non-motorised/ motorised fishing canoe outside the family (in case of death of owner) is enclosed.

II. Transfer of ownership of non-motorised/ motorised fishing canoe outside the family (in case of death of owner)

The transferee has to apply for change in the ownership of the fishing canoe by submitting following documents:

1. Prescribed Application Form I & II with Photograph.
2. Transfer fees of Rs. _____/-
3. Bill/receipt towards the purchase of fire extinguisher along with a photo of fire extinguisher fitted on the fishing canoe (in case of new installation).
4. Sale deed/Gift deed between legal heir of fishing canoe and transferee.

NOTE: 1. On the submission on the above documents, registration number shall be allotted to the applicant.
2. New registration of fishing net/transfer of the net can be done, once number is allotted to the applicant.

III. Issue of VRC and FLC

For issue of VRC and FLC, the applicant has to submit the following documents:

1. Form "A" for issue of FLC
2. Display report of fishing canoe by Fisheries Officer.
3. Copy of updated Fishing Net License Book.
4. A valid copy of insurance of crew members and fishing canoe.
5. Copy of QR coded Aadhaar card of the crew member
