## Sub: - <u>Inviting Quotation for Hiring of Fishing Canoes from Fishermen for Patrolling</u>

Sir,

It is to inform that the Department of Fisheries conducts patrolling duties withing territorial waters of Goa. In order to enhance coastal patrolling, it is proposed to hire fishing canoes from fishermen on an hourly basis at five different static locations.

This arrangement would enable rapid deployment to areas where illegal fishing activities are reported near the shore, thereby facilitating timely interception of offending vessels. The following are the proposed areas

## TERMS AND CONDITIONS

The following are the terms and conditions governing the quotation: -

1. Canoe should have motor of capacity upto 10 HP and length between 30 to 38 feet.

- 2. Minimum Number of crew members on canoe has to be Two including one driver.
- 3. The Canoe should be well equipped with lifesaving equipment, (lifejackets & Lifebuoys), firefighting appliance and other safety gadgets as applicable.
- 4. The Canoe should be in good condition and carry sufficient amount of petrol.
- 5. The Canoe should be given as and when required at disposal of Directorate of Fisheries.
- 6. All the crew members on the board should carry the Aadhaar card.
- 7. The Canoe should carry Vessel Registration Certificate (VRC) and fishing license.
- 8. The rate quoted shall be valid for one year from the date of their opening and per hour basis.
- 9. The quotation should include the rate of all the charges including hiring the Canoe, petrol, crew members and other admissible taxes.
- 10. Number of days and time of Canoe actually used shall be based on the report submitted by the officials of Directorate of Fisheries, Panjim.
- 11. The Director of Fisheries, Panaji reserved the right to reject any or all quotations without assigning any reasons thereof and decision will be final and binding in case of interpretation of any other clause.

In this regard, You are therefore requested to submit your sealed quotation at the Directorate of Fisheries, Head Office, Panaji, for hiring of fishing canoes for patrolling on an hourly basis on or before 21/11/2025.
